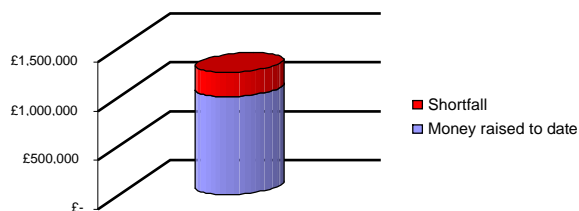


## Advanced Diagnostic Equipment Appeal

- Every year, in India alone, there are 1.8 million new cases of TB and 460,000 deaths.
- We had identified an area of 40 villages with poverty stricken families, who currently have little or no access to medical care.
- MDCF had been working within the local community for over a decade to gain their trust and felt it was now the right time to develop a centre.

### Where are we now?



The hospital project will be formally opened in February 2010 and as such we are now in the final stages of our project. To date the project has raised over a million pounds; all funds received as donations have been employed in the creation of the hospital.

In 2009 we have focussed our efforts on key diagnostic equipment necessary for running such a hospital. To date we have acquired the necessary x-ray equipment and provided a fully functioning laboratory to provide timely and accurate diagnosis to the on-site medical staff.

However if we are to complete our remit, advanced diagnostic equipment are an absolute pre-requisite. Funding for this will entail a further £160,000 in donations. To achieve this we are looking for 60+ people to donate £2,500 each. Every penny counts, so donations in excess of this will always be gratefully received.

We have a deadline of November 2009 to complete this tranche of the fundraising so the centre can be fully operational by February 2010.
